PROGRAM GOALS

To provide young players across the Tri-State Area (including Connecticut, New Jersey, and New York) with an opportunity to participate, free of charge, in an exciting fitness and basketball skills competition; to provide youth organizations with an easily administered program that communicates effectively, supplies consistent and timely information, and delivers all materials on schedule in an effort to provide the highest quality program of its kind.

NBA FIT Dribble, Dish & Swish is intended to encourage youth participation and emphasize both fitness elements and basketball competition. Since there is no registration fee for this program, every boy and girl, 7-12 years of age, may qualify to compete in three (3) levels of competition while emphasizing core basketball skills and focusing on fitness.

COMPETITION RULES

- All participants **MUST** provide a copy of a valid birth certificate or other proof of identification at all levels of competition.
- Each player may participate in only one (1) Local Competition. Competing in more than one (1) Local Competition will result in disqualification.
- If a tie for 1st Place occurs at a **Local Competition**, each player involved in the tie must repeat the competition to determine the Champion. The best time from the tiebreaker will be used to determine the Champion. The Champion's original time will be the time submitted to NBA FIT Dribble, Dish & Swish Headquarters. At the Local Level, if a tiebreaker cannot be held due to participants exiting after competition, then each player involved in the tie will be deemed Co-champion.
- If a tie occurs for 1st Place at the **Regional Competition**, the time from each player's Local Competition will be used to determine the winner. NBA FIT Dribble, Dish & Swish Headquarters will use the submitted time from both players' local competitions to determine the winner at the Regional Competition. The Champion's original time from the Regional Competition will be the time submitted to post against other qualified times for possible advancement to All-Star Finals.
- If a tie occurs for 1st place at **All-Star Finals**, each player must repeat the competition to determine the champion. The best time from the tiebreaker will be used to determine the Champion.
- In the event of cancellations, rescheduling will be determined by NBA FIT Dribble, Dish & Swish officials at the competition site. At the Local Level, the League Director/Local Competition Administrator will be the determining official.
- The NBA and its sponsors, LEJ & Associates, Inc., local and regional coordinators/organizers of NBA FIT Dribble, Dish & Swish, reserve the right to make rulings and recommendations regarding the competition determined to be in the best interest of the program. All rulings and recommendations are final.
- Local Champions/1st place winners in each age and gender group will automatically advance to the Regional Competition. From the Regional Competition, the champion in each age and gender group qualifies to advance to the All-Star Finals. Regional competition champions will then have their times ranked amongst the four (4) Regional Competitions. The top two (2) finishers in each age and gender group will advance to the All-Star Finals.
